

SECTION 2. Said section 197 of said chapter 94 is hereby further amended by inserting after the definition of "D.M.T.", inserted by section 2 of chapter 71 of the acts of 1966, the following definition: —
 "THC", any substance identified chemically as tetrahydrocannabinol by whatever name designated.

Chap. 223. AN ACT REGULATING THE SALE OF FOALS UNDER FIVE MONTHS OF AGE.

Be it enacted, etc., as follows:

Chapter 272 of the General Laws is hereby amended by inserting after section 78 the following section: —

Section 78A. No person shall sell, offer for sale or otherwise dispose of any foal under five months of age other than for the purpose of immediate slaughter or humane killing unless such foal is accompanied by its dam. Violation of this section shall be punished by a fine of not more than one hundred dollars or by imprisonment for not more than six months.

Chap. 224. AN ACT AUTHORIZING LAHEY CLINIC FOUNDATION, INC. TO HOLD ADDITIONAL REAL AND PERSONAL ESTATE.

Be it enacted, etc., as follows:

Lahey Clinic Foundation, Inc., a charitable, medical, educational and scientific organization, organized under the General Laws, is hereby authorized to take and receive by gift, grant, bequest, devise or otherwise, and to hold, any property, real or personal, up to the limit of fifty million dollars, to have and to hold the same upon the terms and for the purposes specified in the agreement of association and the articles of organization, as from time to time heretofore or hereafter amended, of said corporation; and also upon such terms and for such purposes and trusts as may be expressed in any deed or instrument of conveyance or gift made to said corporation, provided the same shall not be inconsistent with the terms and purposes of the aforesaid agreement of association and articles of organization, as from time to time heretofore or hereafter amended.

Chap. 225. AN ACT AUTHORIZING THE WINCHESTER POLICE RELIEF ASSOCIATION, INC. TO PAY CERTAIN SUMS OF MONEY TO MEMBERS UPON THEIR RETIREMENT.

Be it enacted, etc., as follows:

The Winchester Police Relief Association, Inc., a corporation duly established under the laws of the commonwealth, is hereby authorized, upon the retirement of any member in good standing, to pay to such member such sum, not exceeding one thousand dollars, as may be determined by vote of said corporation. Any such payment shall reduce to the extent of such payment any death benefit which would have been paid upon the death of such member. Application for such payment directed to the board of directors of said corporation shall be in writing and shall be made at least one day before the effective date of such retirement.
