

the following sentence: — The word “employer” shall include both the general employer and the special employer in any case where both relationships exist with respect to an employee.

SECTION 2. Section 18 of said chapter 152 is hereby amended by adding the following paragraph: —

In any case where there shall exist with respect to an employee a general employer and a special employer relationship, as between the general employer and the special employer, the liability for the payment of compensation for the injury shall be borne by the general employer or its insurer, and the special employer or its insurer shall be liable for such payment if the parties have so agreed or if the general employer shall not be an insurer or insured person under this chapter.

**Chap. 756.** AN ACT RELEASING THE RIGHT OF REVERSION OF ALL THE RIGHT, TITLE, INTEREST AND ESTATE OF THE COMMONWEALTH IN A CERTAIN PARCEL OF LAND IN THE CITY OF PITTSFIELD.

*Be it enacted, etc., as follows:*

SECTION 1. The armory commission, on behalf of the commonwealth, is hereby authorized to release and surrender to the city of Pittsfield the right of the commonwealth to a reversion to the commonwealth of all the right, title, interest and estate of the commonwealth in and to a certain parcel of land described in a deed dated September twenty-seventh, nineteen hundred and sixty-two, and recorded in the Berkshire County Registry of Deeds, Middle District, Book 753, Page 355, wherein the commonwealth conveyed to the city of Pittsfield said land on condition that title thereto would revert to the commonwealth whenever said land ceased to be used for municipal purposes by said city. The release of said right to reversion shall be approved as to form by the attorney general.

SECTION 2. Chapter five hundred and forty-two of the acts of nineteen hundred and sixty-two is hereby amended by striking out section two.

**Chap. 757.** AN ACT AUTHORIZING THE DIVISION OF FISHERIES AND GAME TO EXCHANGE CERTAIN LAND IN BARNSTABLE COUNTY FOR OTHER LAND OF EQUAL VALUE.

*Be it enacted, etc., as follows:*

The division of fisheries and game in the department of natural resources is hereby authorized to exchange for other land of equal value seven parcels of land in Barnstable county which were transferred by the special military reservation commission to said division for its use on October sixteenth, nineteen hundred and fifty-eight, pursuant to the provisions of chapter six hundred and sixty-five of the acts of nineteen hundred and fifty-five. Said seven parcels of land shall not be subject to the reverter provided by section two of said chapter six hundred and sixty-five. The deeds of exchange shall be approved as to form by the attorney general.
