Beginning at a stone monument on the easterly side of East Mountain Road at the southwesterly corner of land of John S. Lane & Son, Inc., thence S 76° 36' 15" E 721.05' to an iron monument thence S 24° 03' W about 520.38' to an iron monument, the last two courses being along land of said John S. Lane & Son, Inc., thence in the same direction 560' to a point thence N 70° 00' 40" W 548.27' to the easterly side of the East Mountain Road, the last two courses being along other land of grantors thence northerly 1,000' along said road to the point of beginning containing 15 acres more or less. Said parcel of land is to be used by said city solely for playground purposes.

SECTION 2. Title to the land described in section one shall revert to and revest in the commonwealth whenever such land shall cease to be used for the purposes set forth in this act.

SECTION 3. Chapter three hundred and thirty-four of the acts of nineteen hundred and fifty-seven is hereby repealed.

Chap. 891. AN ACT AUTHORIZING THE MAYOR OF THE CITY OF WALTHAM TO APPOINT JOSEPH R. MAHER AS SUPERVISOR OF REGISTRATION AND EQUIPMENT OF THE PARKS AND RECREATION DEPARTMENT OF SAID CITY.

Be it enacted, etc., as follows:

SECTION 1. Notwithstanding the provisions of section eight of chapter thirty-nine of the General Laws or of any other provision of law to the contrary except the provisions of chapter thirty-one of the General Laws, the mayor of the city of Waltham may appoint Joseph R. Maher as supervisor of registration and equipment of the parks and recreation department of said city; provided, however, that said Joseph R. Maher resigns as a member of the city council of said city prior to said appointment.

SECTION 2. This act shall take effect upon its acceptance by the city of Waltham.

Chap. 892. AN ACT AUTHORIZING THE ADDITIONAL PAYMENT OF MONEY FOR THE PREPARATION OF PLANS, SPECIFICATIONS AND LAND ACQUISITION RELATIVE TO CONSTRUCTING AND ORIGINALLY EQUIPPING THE COURT HOUSE FOR THE DISTRICT COURT OF EAST NORFOLK.

Be it enacted, etc., as follows:

Section 1 of chapter 208 of the acts of 1969 is hereby amended by inserting after the word "sums", in line 5, the words: — , including any sum required to be paid for the preparation of plans, specifications and land acquisition over and above the sum authorized by chapter five hundred and seventy of the acts of nineteen hundred and sixty-eight.
