

Chap. 230. AN ACT DESIGNATING THE BRIDGE OVER THE MASSACHUSETTS TURNPIKE AT ST. JAMES STREET IN THE CITY OF NEWTON AS THE FREDERICK J. MCLAUGHLIN BRIDGE.

Be it enacted, etc., as follows:

SECTION 1. The bridge over the Massachusetts turnpike at St. James street in the city of Newton shall be designated and known as the Frederick J. McLaughlin bridge, in memory of Specialist 4 Frederick McLaughlin, who was killed while a member of the United States Army in Vietnam. A suitable marker bearing said designation shall be attached thereto by the Massachusetts Turnpike Authority; provided, however, that the cost of said marker is paid for by any interested party other than said Authority.

SECTION 2. This act shall take effect upon its acceptance by the Massachusetts Turnpike Authority. *Approved April 22, 1970.*

Chap. 231. AN ACT DESIGNATING THE MENTAL HEALTH CENTER BEING CONSTRUCTED IN THE GOVERNMENT CENTER IN THE CITY OF BOSTON AS THE ERICH LINDEMANN MENTAL HEALTH CENTER.

Be it enacted, etc., as follows:

The mental health center, presently being constructed in the Government Center in the city of Boston, shall, upon its completion, be designated and known as the Erich Lindemann Mental Health Center in honor of Dr. Erich Lindemann, a pioneer in the development of community mental health concepts and founder of the first community mental health center in this country. The commissioner of mental health shall cause a suitable tablet bearing said designation and commemorating his pioneer efforts in community mental health to be erected within said building and he shall also cause suitable lettering to be placed upon the outside of said building bearing said designation.

Chap. 232. AN ACT DESIGNATING THE MENTAL HEALTH CENTER IN THE CITY OF FALL RIVER AS THE DR. JOHN C. CORRIGAN MENTAL HEALTH CENTER.

Be it enacted, etc., as follows:

The mental health center in the department of mental health located in the city of Fall River shall be designated and known as the Dr. John C. Corrigan mental health center in memory of Dr. John C. Corrigan for his outstanding efforts in the field of mental health in said city. Said department shall affix a suitable plaque bearing said designation in an appropriate location at said center.

Chap. 233. AN ACT AUTHORIZING CITIES AND TOWNS TO ESTABLISH AN OFFICE OF LANDS AND NATURAL RESOURCES.

Be it enacted, etc., as follows:

Chapter 41 of the General Laws is hereby amended by inserting after section 69F the following section: —

Section 69G. Every city or town may establish an office of lands and natural resources. Said office shall have charge of such lands as may be
