

Chap. 332. AN ACT AUTHORIZING SAVINGS BANKS AND CO-OPERATIVE BANKS TO INVEST IN BONDS OF THE HEALTH AND EDUCATIONAL FACILITIES AUTHORITY.

Be it enacted, etc., as follows:

Section 18 of chapter 614 of the acts of 1968 is hereby amended by striking out the first sentence and inserting in place thereof the following sentence:—Bonds issued by the authority under the provisions of this act are hereby made securities in which all public officers and public bodies of the commonwealth and its political subdivisions, all insurance companies, trust companies, savings banks, co-operative banks, banking associations, investment companies, executors, administrators, trustees and other fiduciaries may properly and legally invest funds, including capital in their control or belonging to them.

Chap. 333. AN ACT DECREASING THE NUMBER OF MEMBERS OF THE BOARD OF WATER COMMISSIONERS OF THE TOWN OF RUSSELL.

Be it enacted, etc., as follows:

Section 10 of chapter 186 of the acts of 1903 is hereby amended by striking out the first four sentences, inserted by section 3 of chapter 158 of the acts of 1964, and inserting in place thereof the following three sentences:—Said town shall elect, by ballot, three persons, residents of the town, who shall constitute a board of water commissioners. At the annual town meeting in the year nineteen hundred and seventy-one three commissioners shall be elected, one for a term of three years, one for a term of two years and one for a term of one year; and the terms of office of the members of the board of water commissioners of the town of Russell elected prior thereto shall thereupon be terminated. Thereafter, upon the expiration of the term of each such member, his successor shall be elected for a term of three years.

Chap. 334. AN ACT PROVIDING FOR THE DESIGNATION OF THE COMMISSIONER OF PROBATION AS A MEMBER, EX OFFICIO, OF THE DRUG REHABILITATION ADVISORY BOARD.

Be it enacted, etc., as follows:

Section 127 of chapter 123 of the General Laws, as appearing in section 1 of chapter 889 of the acts of 1969, is hereby amended by inserting after the word "service", in line 4, the words:—the commissioner of probation.

Chap. 335. AN ACT CLARIFYING THE LAW RELATIVE TO THE ISSUANCE OF SPECIAL SERVICE OR SCHOOL SERVICE BUS PERMITS.

Be it enacted, etc., as follows:

The second paragraph of section 11A of chapter 159A of the General Laws is hereby amended by striking out the fifth sentence, as appearing in chapter 537 of the acts of 1965, and inserting in place
