

Chap. 1046. AN ACT DESIGNATING THE METROPOLITAN DISTRICT COMMISSION INDOOR SWIMMING POOL AND SKATING RINK BEING CONSTRUCTED IN THE TOWN OF WEYMOUTH AS THE WILLIAM A. CONNELL, SR. RECREATION CENTER.

Be it enacted, etc., as follows:

The indoor swimming pool and skating rink being constructed in the town of Weymouth by the metropolitan district commission shall, upon its completion, be designated and known as the William A. Connell, Sr. Recreation Center, in memory of William A. Connell, Sr., a former chairman of the board of selectmen of the town of Weymouth and veteran of World War I. A suitable marker bearing said designation shall be attached thereto by said commission.
