Each licensee holding a harness horse racing meeting on Sunday other than a licensee holding a harness horse racing meeting in connection with a state or county fair, shall pay to the commission on the day following each Sunday of such harness horse racing meeting a sum equal to five and one half per cent of so much of the total amount deposited on the preceding Sunday by the patrons so wagering at such meeting as does not exceed four hundred thousand dollars, six and three quarters per cent of so much thereof as exceeds four hundred thousand dollars but does not exceed four hundred and fifty thousand dollars, seven and one quarter per cent of so much thereof as exceeds four hundred and fifty thousand dollars but does not exceed five hundred thousand dollars, seven and three quarters per cent of so much thereof as exceeds five hundred thousand dollars but does not exceed five hundred and fifty thousand dollars, eight and one quarter per cent of so much thereof as exceeds five hundred and fifty thousand dollars but does not exceed six hundred thousand dollars, eight and three quarters per cent of so much thereof as exceeds six hundred thousand dollars but does not exceed six hundred and fifty thousand dollars and nine and one quarter per cent of all over six hundred and fifty thousand dollars, said percentages to be paid from the eighteen per cent withheld, as provided in this section, from the total amount wagered.

**Chap. 209.** AN ACT DIRECTING THE DEPARTMENT OF NATURAL RESOURCES TO CONVEY CERTAIN LAND OF THE COMMONWEALTH IN THE TOWN OF WRENTHAM TO THE COUNTY OF NORFOLK.

*Whereas,* The deferred operation of this act would tend to defeat its purpose, which is to provide forthwith for the use for highway purposes by Norfolk county of certain land of the commonwealth, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

*Be it enacted, etc., as follows:*

The department of natural resources, on behalf of the commonwealth, is hereby authorized and directed to convey to Norfolk county, to be used for highway purposes, the land of the commonwealth under the control of said department, located in the town of Wrentham, described in a plan of land entitled, "Plan and Profile showing the relocation and widening of a portion of Madison street, Wrentham from Washington street (Route 1) to East street," dated December, 1948 and recorded with the registry of deeds in Norfolk county in plan book 148, plans numbered 1181 to 1190, inclusive, and more particularly described as follows:—

*Parcel No. 5.* 9,200 square feet, more or less, and a slope easement as shown on said plans.

*Parcel No. 7.* 4,150 square feet, more or less, and a slope easement as shown on said plans.

*Parcel No. 8.* 7,800 square feet, more or less, and a slope easement as shown on said plans.

*Parcel No. 13.* 9,000 square feet, more or less, and a slope easement as shown on said plans.

*Parcel No. 14.* 8,400 square feet, more or less, and a slope easement as shown on said plans.

**Chap. 210.** AN ACT MAKING APPROPRIATIONS FOR THE MAINTENANCE OF HAMPSHIRE COUNTY, ITS DEPARTMENTS, BOARDS, COMMISSIONS AND INSTITUTIONS, OF SUNDRY OTHER SERVICES, FOR CERTAIN PERMANENT IMPROVEMENTS, FOR INTEREST AND DEBT REQUIREMENTS, AND TO MEET CERTAIN REQUIREMENTS OF LAW AND GRANTING A COUNTY TAX FOR SAID COUNTY.

*Be it enacted, etc., as follows:*

SECTION 1. To provide for the maintenance of Hampshire county, its departments, boards, commissions and institutions, of sundry other services, for certain permanent improvements, for interest and debt requirements, and to meet certain requirements of law, the following sums are hereby appropriated, subject to the provisions of law regulating the disbursement of county funds and the approval thereof for the year nineteen hundred and seventy-two.
