To accompany the petition of Ralph C. Mahar and others that the name of the Massachusetts State College be changed to the University of Massachusetts. Education.

The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Forty-Seven.

AN ACT CHANGING THE NAME OF THE MASSACHUSETTS
STATE COLLEGE TO THE UNIVERSITY OF MASSACHUSETTS.

*Be it enacted by the Senate and House of Representatives
in General Court assembled, and by the authority of the
same, as follows:*

1 SECTION 1. The name of the Massachusetts state
2 college is hereby changed to the University of Massa-
3 chusetts.

1 SECTION 2. Chapter 75 of the General Laws is
2 hereby amended by striking out section 1, as appear-
3 ing in the Tercentenary Edition, and inserting in place
4 thereof the following section:—

5 *Section 1.* The university of Massachusetts shall
6 continue to be a state institution.

1 SECTION 3. Section 2 of said chapter 75, as so ap-
2 pearing, is hereby amended by striking out the word
3 “college” in the first line and inserting in place thereof
4 the word:— university.

1 SECTION 4. Section 4 of said chapter 75, as so ap-
2 pearing, is hereby amended by striking out the word
3 “college” in the first line and inserting in place thereof
4 the word: — university.

1 SECTION 5. Section 9 of said chapter 75, as so ap-
2 pearing, is hereby amended by striking out the word
3 “college” in the second and in the fourth line and in-
4 serting in place thereof the word: — university.

1 SECTION 6. Section 10 of said chapter 75, as so ap-
2 pearing, is hereby amended by striking out the word
3 “college” in the third line and inserting in place thereof
4 the word: — university.

1 SECTION 7. Section 11 of said chapter 75, as so ap-
2 pearing, is hereby amended by striking out the word
3 “college” in the second line and inserting in place
4 thereof the word: — university.

1 SECTION 8. Secton 14 of said chapter 75, as so ap-
2 pearing, is hereby amended by striking out the word
3 “college” in the second and in the sixth line and in-
4 serting in place thereof the word: — university.

1 SECTION 9. Section 15 of said chapter 75, as so ap-
2 pearing, is hereby amended by striking out the word
3 “college” in the second line and inserting in place
4 thereof the word: — university.

1 SECTION 10. The caption preceding section 9 of
2 said chapter 75 is hereby stricken out and the follow-
3 ing caption inserted in place thereof: — REGULATION
4 OF UNIVERSITY.

1 SECTION 11. When used in any statute, ordinance,
2 by-law, rule or regulation, the phrase "Massachusetts
3 state college", or any words connoting the same, shall
4 mean the university of Massachusetts, unless a con-
5 trary intent clearly appears.
