AN ACT RELATIVE TO THE TENURE OF EMPLOYMENT OF
EDITH B. HAYS, LIBRARIAN OF THE EDGELL PUBLIC
LIBRARY IN FRAMINGHAM.

*Be it enacted by the Senate and House of Representatives
in General Court assembled, and by the authority of the
same, as follows:*

1 Notwithstanding any provision of law to the con-
2 trary, the employment of Edith B. Hays, librarian
3 of the Edgell Public Library in Framingham, may be
4 continued until March first, nineteen hundred and
5 fifty, but the compensation paid to said librarian
6 from March first, nineteen hundred and forty-eight,
7 to said date shall not be subject to the deductions
8 provided for by chapter thirty-two of the General
9 Laws or any other retirement system of which said
10 librarian is a member.

1. Short title.—This Act may be cited as the Companies Act, 1862.

2. Interpretation.—In this Act, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, to-wit:

1.
