AN ACT TO REQUIRE THE PAYMENT OF CERTAIN COMPENSATION TO DEPENDENTS OF AN EMPLOYEE INJURED WHO HAD RECEIVED AN INJURY ARISING OUT OF THE COURSE OF HIS EMPLOYMENT.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Section 31 of chapter 152 of the General Laws, as  
2 most recently amended by chapter 357, acts of 1950,  
3 is hereby amended by adding at the end the following  
4 paragraph:—

5 In all cases under this section, for such periods as  
6 compensation has not been paid the employee before  
7 his death, the dependent or dependents entitled to  
8 compensation under this section shall be paid such  
9 benefits as may have been due the employee before  
10 his death. The provisions of this section shall not  
11 change or modify the provisions contained in sec-  
12 tion thirty-six A, as most recently amended by chap-  
13 ter four hundred and forty-five of the acts of nineteen  
14 hundred and fifty.
