AN ACT PERMANENTLY ESTABLISHING APRIL FIFTEENTH AS THE DATE FOR THE FILING OF INCOME TAX RETURNS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. Section 24 of chapter 62 of the General
- 2 Laws, as amended by section 2 of chapter 45 of the
- 3 acts of 1943, is hereby further amended by striking
- 4 out, in line 8, the words "March first" and inserting
- 5 in place thereof the words: April fifteenth, so as
- 6 to read as follows: Section 24. Returns under sec-
- 7 tions twenty-two and twenty-three shall be accom-
- 8 panied by a written declaration that they are made
- 9 under the penalties of perjury, and shall be filed with
- 10 the commissioner, shall be made in such form as the
- 11 commissioner prescribes, and shall contain such
- 12 further information as he deems pertinent. Except
- 13 as otherwise provided in this chapter, the return
- 14 shall be made on or before April fifteenth each year
- 15 and shall relate to the income received during the
- 16 year ending on December thirty-first preceding.
 - 1 Section 2. Section five of chapter two hundred
 - 2 and forty-six of the acts of nineteen hundred and
 - 3 fifty-three is hereby repealed.
