11 thirteen H other than that which is specifically per-
12 mitted or provided for in any such plan as officially
13 approved by the commissioner of insurance in ac-
14 cordance with the provisions of said section. Who-
15 ever violates any provision of this section shall be
16 punished by a fine of not less than one hundred nor
17 more than one thousand dollars for each such viola-
18 tion, and in the case of any such violation by any
19 person duly licensed under any provision of this chap-
20 ter, the commissioner shall suspend his license for
21 such period of time as he in his discretion deems
22 feasible.
