### RESOLVE IN FAVOR OF JOHN CABRAL OF SEEKONK.

1 *Resolved*, That, for the purpose of discharging a  
2 moral obligation of the commonwealth, and subject  
3 to appropriation, there shall be allowed and paid out  
4 of the state treasury the sum of                    dollars to  
5 John Cabral of the town of Seekonk, in reimburse-  
6 ment for the loss of certain hogs destroyed in the year  
7 nineteen hundred and fifty-three by reason of the  
8 law enacted in said year providing for the eradication  
9 of certain animal diseases.

Resolved, That the following bill be passed with amendments as reported by the committee on the part of the Senate to which it was referred, and that the same be reported to the Senate with amendments.
