SENATE, May 20, 1954.

The Senate committee on Ways and Means, to whom was referred the Senate Bill to authorize the Trustees of the University of Massachusetts to establish in the city of Gloucester a school of fisheries and a fisheries research station (Senate, No. 246); the Senate Bill providing for the extension of a public wharf in the town of Mattapoisett (Senate, No. 628); the House Bill relative to the registration of labels and trade marks (House, No. 88, changed and amended); the House Bill further relating to the rights of creditors and administrators in the real estate of deceased persons (House, No. 382); the House Bill relative to the recovery of stolen and lost dogs and cats (printed as House, No. 460); the House Bill relative to security for payment for construction or manufacture of any component part of any public work (House, No. 2430); the House Bill providing for the establishment of a state park at Dighton Rock, so called, in the town of Berkley (House, No. 2517); the House Bill providing for a payment for James J. Murphy of Fall River, a former member of the State Police (House, No. 2538, amended); the House Resolve providing for an investigation and study by the department of public works relative to the construction of a certain footbridge or ramp over the Boston and Maine Railroad in the city of Lawrence (House, No. 2658), report the accompanying Order (Senate, No. 789).

SENATE, May 20, 1954.

*Ordered,* That the senate committee on ways and means be authorized to sit during the recess of the general court to study the subject matter of current senate document numbered 246, to authorize the trustees of the University of Massachusetts to establish in the city of Gloucester a school of fisheries and a fisheries research station; of current Senate document numbered 628, providing for the extension of a public wharf in the town of Mattapoisett; of current House document numbered 88, relative to the registration of labels and trade marks; of current House document numbered 382 further relating to the rights of creditors and administrators in the real estate of deceased persons; of current House document numbered 460, relative to the recovery of stolen and lost dogs and cats; of current House document numbered 2430, relative to security for payment for construction or manufacture of any component part of any public work; of current House document numbered 2517, providing for the establishment of a state park at Dighton Rock, so called, in the town of Berkley; of current House document numbered 2538, providing for an annuity for James J. Murphy of Fall River, a former member of the state police; of current House document numbered 2658, providing for an investigation and study by the department of public works relative to the construction of a certain foot-bridge or ramp over the Boston and Maine Railroad in the city of Lawrence. Said committee shall report to the general court the results of its investigation and study, together with drafts of legislation necessary to carry such recommendations into effect, by filing the same with the clerk of the senate not later than the first Wednesday in December of the current year.
