## The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Fifty-Five.

AN ACT FURTHER REGULATING THE GRANTING OF ASSISTANCE  
TO PERSONS WHO ARE DISABLED.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 4 of chapter 118D of the General  
2 Laws, as appearing in section 2 of chapter 741 of the  
3 acts of 1951, is hereby amended by adding at the end  
4 thereof the following paragraph: —

5 Each local board of public welfare shall include in the  
6 budget of each recipient an item, to be known as "Recre-  
7 ational and Cultural Activities", under which there shall  
8 be paid to each such recipient, in addition to any other  
9 sum paid to him, the sum of five dollars monthly. Cities  
10 and towns making payments under this paragraph shall  
11 be reimbursed by the commonwealth to the full amount  
12 thereof, notwithstanding any other provision of law.

1 SECTION 2. This act shall take effect as of January  
2 first, nineteen, hundred and fifty-five.
