The Commonwealth of Wassachusetts

In the Year One Thousand Nine Hundred and Fifty-Five.

An Act authorizing the department of public safety to provide police service for the massachusetts turnpike authority.

1 Whereas, The deferred operation of this act would tend

2 to defeat its purpose, which is to provide forthwith for

3 the effective policing of the Massachusetts turnpike, or

4 portion thereof, by the state police, therefore this act is

5 hereby declared to be an emergency law, necessary for

6 the immediate preservation of the public safety and

7 convenience.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. Chapter 22 of the General Laws is hereby
- 2 amended by inserting after section 9F, inserted by sec-
- 3 tion 1 of chapter 474 of the acts of 1953, the following
- 4 two sections: -
- 5 Section 9G. The commissioner is hereby authorized
- 6 and directed to enter into an agreement or contract with
- 7 the Massachusetts Turnpike Authority for police service 8 to be furnished to the Authority by the department.
- 9 Said agreement or contract shall fix the legal responsi-
- 10 bility pertaining to the operation and maintenance of
- 11 such service and shall include, among other provisions,
- 12 a provision for payments to the commonwealth for the
- 13 cost of retirement, compensation of injured officers, sick
- 14 leave, or other employee benefits, and a minimum allow-
- 15 ance for departmental supervision. Said agreement or
- 16 contract shall also include a provision that all expenses
- 17 of every name and nature incurred by the department
- 18 in supplying such police service shall, upon proper

19 requisition, be paid by the authority as such expenses 20 are incurred.

Section 9H. The commissioner may appoint and or-21 22 ganize a state police force of such size as he and the 23 Authority may agree upon, in addition to any other force 24 authorized by law, to be assigned to the Massachusetts 25 Turnpike Authority to meet the requirements of section 26 fifteen of chapter three hundred and fifty-four of the acts 27 of nineteen hundred and fifty-two. The officers of the 28 state police force, so appointed and so assigned, shall 29 have the same powers and be subject to the same qualifi-30 cations, orders or restrictions as officers appointed under 31 the provisions of section nine A of chapter twenty-two; 32 provided, however, that, during such assignment and 33 except as the commissioner shall determine that an 34 emergency exists or is threatened, such officers, in the per-35 formance of their duties, shall be subject to the opera-36 tional control of the Authority and a superintendent or 37 assistant superintendent of police of the Authority who 38 shall be appointed by the Authority, but shall at all 39 times be under the administrative and disciplinary con-40 trol of the commissioner. Any officer, so appointed anp 41 so assigned, may be reassigned to general duties the same 42 as those officers appointed under the provisions of said 43 section nine A, and any officer appointed as provided in 44 section nine A may be substituted by assignment for any 45 officer appointed under this section. Any officer so 46 appointed, assigned or reassigned shall for the purposes 47 of salary, seniority, retirement or other rights be con-48 sidered as appointed under the provisions of said section 49 nine A, and the assignment or reassignment shall in no 50 way impair any rights to which an officer may be en-51 titled, and such officer shall at all times be considered to 52 be an employee of the commonwealth.

Any officer assigned to duty on the turnpike shall 54 receive his entire compensation during the period of his 55 assignment from the Massachusetts Turnpike Authority, 56 and the appointment and assignment of such officers 57 by the commissioner shall in no way be considered a vio58 lation of any provisions of chapter twenty-nine. All 59 assignments and reassignments to the Massachusetts 60 Turnpike Authority hereunder and under section nine A, 61 except as the commissioner shall determine that an 62 emergency exists or is threatened, shall be subject to the 63 approval of the Authority acting through its superintend-64 ent or assistant superintendent of police appointed as 65 provided above.

Section 2. Members of the uniformed branch of the 2 division of state police in the department of public 3 safety, during such period or periods as they may be 4 assigned or reassigned to the Massachusetts Turnpike 5 Authority, under the provisions of this act, shall be con-6 sidered as employees of the commonwealth and entitled 7 to all rights and benefits accorded employees of the 8 commonwealth under the provisions of chapter thirty-9 two of the General Laws. The Authority is hereby 10 authorized and directed to make such deductions as are 11 required to be made by chapter thirty-two and to trans-12 mit such deductions monthly, together with a report 13 showing the amount of regular compensation paid to and 14 the amount deducted from the salary of each such mem-15 ber for retirement purposes, to the state board of re-16 tirement.
