By Mr. Lawton of Brockton, petition of James R. Lawton that the Commissioner of Public Works be authorized to construct a sidewalk on Centre Street in the city of Brockton. Highways and Motor Vehicles.

AN ACT AUTHORIZING THE COMMISSIONER OF PUBLIC WORKS TO CONSTRUCT A SIDEWALK ON THE SOUTH SIDE OF CENTRE STREET, DESIGNATED AS ROUTE ONE HUNDRED AND TWENTY-THREE IN THE CITY OF BROCKTON.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The commissioner of public works shall
2 be authorized to construct a bituminous concrete side-
3 walk on Centre street from Empire avenue on the south
4 sidewalk to the Abington line, a distance of approxi-
5 mately seventy-five hundred feet in the city of Brockton,
6 being located on Route 123.

1 SECTION 2. The commissioner of public works should
2 furnish and set necessary curb, prepare gravel base,
3 furnish and set the bituminous concrete, do all necessary
4 drainage and such other work that may be required to
5 complete the sidewalk construction as herein provided,
6 and the construction should be done at no expense to
7 the city of Brockton.
