Harrison, Jr., the Adjutant General, for legislation relative to the care, custody and preservation of certain flags carried in time of war by military or naval organizations and to make the State Superintendent of Buildings the custodian thereof. State Administration.

AN ACT TO PROVIDE FOR THE PROPER CARE, CUSTODY AND PRESERVATION OF FLAGS CARRIED IN TIME OF WAR BY ORGANIZATIONS OF MASSACHUSETTS MEN OR WOMEN IN THE MILITARY OF NAVAL SERVICE OF THE UNITED STATES AND TO MAKE THE STATE SUPERINTENDENT OF BUILDINGS THE CUSTODIAN THEREOF.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. Chapter 8 of the General Laws is hereby 2 amended by inserting after section 17 the following sec-3 tion:—
- 4 Section 17A. The state superintendent of buildings
- 5 is hereby designated as the custodian of the flags car-
- 6 ried in time of war by organizations of Massachusetts
- 7 men or women in the military or naval service of the
- 8 United States, which flags are now in the possession
- 9 of the commonwealth or which in the future may come
- 10 into such possession.
- 11 He shall exercise proper care, custody and preserva-
- 12 tion of such flags, and shall keep on file at all times
- 13 a record open to public inspection, containing such
- 14 details concerning such flags and including such picto-
- 15 rial representations as he may deem proper, and shall
- 16 give an account thereof each year in his annual report.

17 He shall have supervision over the Hall of Flags, 18 and all cases and cabinets therein, and over all cases 19 and cabinets in Doric Hall or elsewhere in the state 20 house wherein any such flags as are referred to herein 21 are now or may in the future be on public display.

He may provide proper streamers and marks of in-23 signia for identification of any of the flags referred to 24 herein. The standard given to the regiment of Massa-25 chusetts volunteers in Mexico by General Winfield 26 Scott, and now in the quarters of the senate, shall be 27 retained therein, and he shall cause a proper case or 28 cabinet to be provided therefor. In the event that 29 other flags of the Mexican War, the Civil War, the 30 Spanish-American War or World War I shall come into 31 the possession of the commonwealth, he shall cause 32 suitable provision to be made for their preservation 33 with the other flags of the respective units involved. 34 In the event that flags of World War II shall come into 35 the possession of the commonwealth, he shall cause 36 proper cases or cabinets to be provided therefor, either 37 in the Hall of Flags or in Doric Hall.

38 The flags referred to herein shall not be removed 39 from the state house without the express permission of 40 the general court.

- 1 Section 2. The adjutant general shall, forthwith, 2 turn over to the superintendent of buildings all records, 3 documents, memoranda and other papers relating to 4 the Hall of Flags, and said cases and cabinets, and flags 5 now in his custody.
- 1 Section 3. This act shall take effect upon its passage.
