## The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Fifty-Seven.

AN ACT PROVIDING FOR THE PAYMENT OF UNEMPLOYMENT COMPENSATION IN CERTAIN CASES OF EMPLOYEES WHO WORK LESS THAN TWO THOUSAND HOURS IN ANY CALENDAR YEAR.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Notwithstanding any other provision of law, any person  
2 who, having complied with all applicable provisions of the  
3 unemployment security law, has been unemployed for less  
4 than two thousand hours during any calendar year, may, dur-  
5 ing the January next ensuing, apply for and receive in a lump  
6 sum unemployment compensation at the rate provided in said  
7 law for the period during which he was unemployed. Such  
8 compensation shall be figured on the basis of a forty-hour  
9 work week and a fifty-two week work year.
