

SECTION 2. This act shall take effect upon its acceptance by the city council of said city, subject to the provisions of its charter, but not otherwise.

**Chap. 197.** AN ACT AUTHORIZING THE NORTH PARISH OF NORTH ANDOVER TO INCREASE THE AMOUNT OF PROPERTY IT MAY HOLD TO ONE MILLION DOLLARS.

*Be it enacted, etc., as follows:*

Section 3 of chapter 153 of the acts of 1905 is hereby amended by striking out, in line 2, the words "hundred thousand" and inserting in place thereof the word:— million,— so as to read as follows:—

SECTION 3. Said corporation may hold real and personal property to the amount of one million dollars, the income of which shall be appropriated exclusively to parochial purposes.

**Chap. 198.** AN ACT DESIGNATING A CERTAIN TRAFFIC CIRCLE IN THE CITY OF LOWELL AS THE CAPTAIN GEORGE T. WALTERS CIRCLE.

*Be it enacted, etc., as follows:*

The traffic circle at the northerly approach to the Quinn-Holmes bridge over the Merrimack river in the city of Lowell shall be known and designated as the Captain George T. Walters Circle, and a suitable marker bearing said designation shall be erected and maintained thereon by the department of public works.

**Chap. 199.** AN ACT RELATIVE TO THE TAKING, TRANSPORTING AND SALE OF SCALLOPS.

*Be it enacted, etc., as follows:*

SECTION 1. The first paragraph of section 80 of chapter 130 of the General Laws, as appearing in section 1 of chapter 598 of the acts of 1941, is hereby amended by striking out, in line 2, the words "and except that this section shall not apply to scallops,".

SECTION 2. The second paragraph of said section 80 of said chapter 130, as so appearing, is hereby amended by inserting after the word "shellfish", in line 1, the words:— , except scallops or sea scallops,.

SECTION 3. The second paragraph of section 81 of said chapter 130 is hereby amended by striking out the last sentence, added by section 2 of chapter 99 of the acts of 1945.

SECTION 4. Section 82 of said chapter 130 is hereby amended by striking out the last sentence, added by section 3 of said chapter 99 of the acts of 1945.

SECTION 5. The first paragraph of section 92 of said chapter 130, as appearing in section 1 of said chapter 598 of the acts of 1941, is hereby amended by adding at the end the following sentence:— Said box, carton, tray or container shall also be marked in the same manner with the number of the certificate under which said scallops were removed or with such other identification as may be required by the director by rule or regulation, which he is hereby authorized to adopt.
