
By Mr. Fletcher of Chelmsford, petition of Vernon R. Fletcher that the North Chelmsford Water District be authorized to sell and distribute water through the Tyngsborough Water District. Water Supply.

The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Fifty-Eight.

AN ACT AUTHORIZING THE NORTH CHELMSFORD WATER DISTRICT TO SELL AND DISTRIBUTE WATER THROUGH THE TYNGSBOROUGH WATER DISTRICT.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Chapter 73 of the acts of 1946 is hereby amended by inserting
- 2 after section 2 the following new section:—
- 3 *Section 2A.* The said North Chelmsford Water District may
- 4 extend its conduits, pipes, mains or other works into the town of
- 5 Tyngsborough, and may distribute water through the Tyngs-
- 6 borough Water District or any part thereof, and may regulate
- 7 the use of such water and fix and collect rates for the use of the
- 8 same, as may be mutually agreed upon by the commissioners of
- 9 said Tyngsborough Water District and the board of water
- 10 commissioners of the North Chelmsford Water District, or, in
- 11 case of failure to agree, as may be fixed by the state department
- 12 of public utilities; and the said Tyngsborough Water District
- 13 may make such contract with the North Chelmsford Water
- 14 District for water for the extinguishment of fires and other
- 15 purposes, as may be agreed upon between said Tyngsborough
- 16 Water District, and the said North Chelmsford Water District.
- 17 The said North Chelmsford Water District may establish and
- 18 maintain fountains and hydrants and may relocate or discon-
- 19 tinue the same.

That the said Commonwealth of Massachusetts doth hereby certify that the following is a true and correct copy of the report of the Board of Commissioners of the Public Health, as the same appears from the records of the said Commonwealth.

Attest: By the Clerk of the said Commonwealth, in General Court assembled, and by the majority of the same, as follows:

- 1 Chapter 73 of the laws of 1858 is hereby amended by inserting
- 2 after section 2 the following new section:
- 3 Section 21. The said Board of Commissioners of the Public Health
- 4 shall have the honor, power, means or other words in the fourth
- 5 article of the said laws, and may distribute water through the pipes
- 6 through the said District or any part thereof, and take water
- 7 from any well, cistern, or other source, for the use of the
- 8 same, as may be necessary to supply the consumption of
- 9 said Commonwealth, either at once and the land of water
- 10 throughout the said Commonwealth, or in
- 11 any or either of them, as may be necessary in any district.
- 12 It shall be the duty of the said Board of Commissioners
- 13 to enter into a contract with the State, for the purchase of
- 14 water for the use of the said Commonwealth, and to
- 15 purchase the same in such quantities and at such
- 16 prices as may be necessary for the use of the said
- 17 Commonwealth, and the said Board of Commissioners
- 18 shall have the honor, power, means or other words in the
- 19 said laws, and may take water from any well, cistern, or
- 20 other source, for the use of the said Commonwealth.
