By Mr. Riley of Auburn, petition of John E. Riley for legislation to extend the term of office of the treasurer of the Hillcrest Water District in the town of Leicester from one year to two years. Water Supply.

AN ACT EXTENDING THE TERM OF OFFICE OF THE TREASURER OF THE HILLCREST WATER DISTRICT FROM ONE YEAR TO TWO YEARS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 9 of chapter 358 of the acts of 1950 is
2 hereby amended by striking out the fourth sentence and insert-
3 ing in place thereof the following sentence:— At the annual
4 meeting of the district which shall be held in nineteen hundred
5 and fifty-nine, the district shall elect by ballot, for a term of one
6 year, a clerk who shall be elected annually thereafter, and for a
7 term of two years, a treasurer, who shall be elected every second
8 year thereafter.

1 SECTION 2. This act shall take effect upon its acceptance at
2 either an annual or special district meeting.
