HOUSE OF REPRESENTATIVES, June 30, 1958.

The committee on Ways and Means, to whom were referred the Bill authorizing and directing the Department of Natural Resources to construct a ski tow on Mount Grace in the town of Warwick (Senate, No. 85); the Bill authorizing the re-valuation of certain land in the towns of Florida, Savoy and Clarksburg taken by the Department of Natural Resources, for the purpose of adjusting the amounts of money paid each town by the Commonwealth for the land taken in lieu of taxes (House, No. 808); the Bill authorizing the Department of Natural Resources to expend certain moneys for the purchase of fire equipment, for the payment of salaries of certain employees of the Bureau of Forest Fire Control of the Division of Forests and Parks of the Department of Natural Resources and for the maintenance of forests and roads and fire trails therein (printed in House, No. 2709, page 13); the Bill providing for the establishment of a state forest park in the Middlefield State Forest (House, No. 2975); and the petition (accompanied by bill, House, No. 1176) of Sidney Q. Curtiss, Otto F. Burkhardt and Silvio O. Conte that the Commissioner of Natural Resources be authorized to acquire certain land in Great Barrington adjoining the East Mountain State Forest, report the accompanying resolve (House, No. 3156).

RESOLVE INCREASING THE SCOPE OF THE SPECIAL COMMISSION ESTABLISHED TO MAKE AN INVESTIGATION AND STUDY RELATIVE TO HUNTING AND FISHING WITHIN THE COMMONWEALTH AND CERTAIN MATTERS RELATING THERETO.

1 *Resolved*, That the unpaid special commission, established by
2 chapter eighty-four of the resolves of nineteen hundred and
3 fifty-five, and most recently revived and continued by chapter
4 forty-two of the resolves of the current year, shall include in its
5 investigation and study the subject matter of current senate
6 document numbered 85, authorizing and directing the depart-
7 ment of natural resources to construct a ski tow on Mount
8 Grace in the town of Harwick; of current house document
9 numbered 808, authorizing the re-valuation of certain land in the
10 towns of Florida, Savoy and Clarksburg taken by the Depart-
11 ment of Natural Resources for the purpose of adjusting the
12 amounts of money paid each town by the commonwealth for the
13 land taken in lieu of taxes; of current house document numbered
14 1176, authorizing the commissioner of natural resources to ac-
15 quire certain land in Great Barrington; of current house docu-
16 ment numbered 2709, authorizing the department of natural
17 resources to expend certain moneys for the purchase of fire
18 equipment for the payment of salaries of certain employees of
19 the Bureau of Forest Fire Control of the Division of Forests
20 and Parks of the Department of Natural Resources and for the
21 maintenance of forests and roads and fire trails therein; of cur-
