AN ACT MAKING PERMANENT CERTAIN TEMPORARY POSITIONS IN  
THE STATE DEPARTMENT OF PUBLIC WORKS IN DISTRICT FIVE.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Notwithstanding any provision of general law to the contrary,  
2 or any provision of the general appropriation act of nineteen  
3 hundred and fifty-eight or of any provision of any supple-  
4 mentary appropriation act for the year nineteen hundred and  
5 fifty-eight, the number of permanent positions duly approved in  
6 each item of appropriation for personal services shall be in-  
7 creased to include every temporary position as a number four  
8 man in the department of public works in district five for which  
9 for a continuous period of three years or more past from Janu-  
10 ary first, nineteen hundred and fifty-five, compensation has  
11 been duly paid or authorized under the same or a like item in  
12 connection with the maintenance of the department of public  
13 works. The director of personnel shall, by title and subject to  
14 the approval of the commission on administration and finance,  
15 certify to the budget commissioner, the comptroller, the director  
16 of civil service, the commissioner of public works and the senate  
17 and house committees on ways and means, each such position  
18 to be included.
