AN ACT PROVIDING A TAX EXEMPTION ON REAL ESTATE OWNED BY CERTAIN VETERANS OF WORLD WAR I.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Paragraph (c) of clause twenty-second of section 5 of chapter
2 59 of the General Laws, as most recently amended by section 2
3 of chapter 381 of the acts of 1956, is hereby further amended by
4 inserting after the word "forces" in line 5, the following words:
5 — and soldiers and sailors of World War I who were discharged
6 or released from such service in any manner other than dishonor-
7 ably, who have a total disability determined by the veterans'
8 administration or who are blind in one or both eyes, though non-
9 service connected, shall have a disability rating of ten per cent
10 upon attaining the age of sixty-five, — so as to read as follows: —

11 (c) Soldiers and sailors, as defined in paragraph (a) who, as a
12 result of disabilities contracted while in such service and in the
13 line of duty, have a disability rating of ten per cent or more as
14 determined by the veterans' administration or by any branch of
15 the armed forces **and soldiers and sailors of World War I**
16 **who were discharged or released from such service in any**
17 **manner other than dishonorably, who have a total dis-**
18 **ability determined by the veterans' administration or who**
19 **are blind in one or both eyes, though non-service con-**
20 **ected, shall have a disability rating of ten per cent upon**
21 **attaining the age of sixty-five.**
