

By Mr. Albro of Harwich, petition of Everett C. Small for legislation to authorize the Commissioner of the Department of Public Works to convey to the town of Chatham certain state land located in said town. Harbors and Public Lands.

AN ACT AUTHORIZING THE CONVEYANCE BY THE COMMONWEALTH TO
THE TOWN OF CHATHAM OF CERTAIN LAND IN SAID TOWN.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. The commissioner of the department of public
2 works, in the name of and on behalf of the commonwealth, is
3 hereby authorized subject to the approval of the governor and
4 council, to convey to the town of Chatham, for the sum of one
5 dollar, the following parcels of land owned by the commonwealth
6 and under the control of said department located in said town,
7 bounded and described as follows:—

8 1. *Bounded:*—

9 Northerly, by the mean low water mark of land of Robert M.
10 and Mary Louise Horne shown as part of Lot C on Land Court
11 Plan 12208-U, lying westerly of Lot 84 on Land Court Plan
12 12208-I, by the mean low water mark land of the Town of
13 Chatham shown as Lot 84 on Land Court Plan 12208-I, and by
14 the mean low water mark of land of Robert M. and Mary
15 Louise Horne shown as part of Lot C on Land Court Plan
16 12208-U, lying easterly of said Lot 84;

17 Westerly, by the waters of Stage Harbor;

18 Southerly, by land and flats of David M. and Anne Hall
19 Davis, being that portion of the land on Land Court Plan
20 22613-D lying westerly of Lot 3 shown on said plan, by Lot 3
21 shown on said plan and being land of said David M. and Anne
22 Hall Davis, and by the mean low water mark of land and flats
23 of Edward R. Noyes shown as a portion of Lot 4 on said plan
24 and lying easterly of said Lot 3; and

25 Easterly, by the waters of Chatham Harbor, and being shown
26 as a portion of Stage Harbor on said Land Court Plan 22613-D.

27 *2. Bounded:—*

28 Northerly, by Lot 3 shown on Land Court Plan 22613-C, and
29 being land of David M. and Anne Hall Davis;

30 Easterly, by the easterly line of said Lot 3 extended southerly
31 to Lot 2 on Land Court Plan 22613-C;

32 Southerly, by Lot 2 shown on said Land Court Plan, and
33 being land of said David M. and Anne Hall Davis; and

34 Westerly, by the westerly line of said Lot 2 extended north-
35 erly to said Lot 3.

36 *3. Bounded:—*

37 Westerly, by the easterly line of Lot 3 shown on Land Court
38 Plan 22613-D extended southerly to Lot 2 shown on said plan;

39 Northerly, easterly and southerly, by the low water mark of
40 the creek leading easterly from Stage Harbor as shown on Land
41 Court Plan 22613-A, at land of Edward R. Noyes shown as
42 Lot 4 on Land Court Plan 22613-D.

43 *4. Bounded:—*

44 Easterly, by the westerly line of Lot 3 shown on Land Court
45 Plan 22613-D extended southerly to Lot 2 shown on said plan;

46 Southerly, by mean low water line of land of David M. and
47 Anne Hall Davis shown on said Plan;

48 Westerly, by waters of Stage Harbor; and

49 Northerly, by the mean low water line of said land of David M.
50 and Anne Hall Davis shown on aforementioned Plan.

1 SECTION 2. This act shall take effect upon its passage.
