The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Sixty.

AN ACT AUTHORIZING THE TOWN OF BOURNE TO PROVIDE FOR THE OPERATION AND MAINTENANCE OF DENTAL CLINICS IN ITS PUBLIC SCHOOLS BY ITS SCHOOL COMMITTEE.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding any provision of section fifty
2 of chapter one hundred and eleven of the General Laws or any
3 other general law or any special law to the contrary, the town
4 of Bourne may, by vote of said town at an annual or special
5 town meeting called for the purpose, provide that appropria-
6 tions made for the purpose of the operation and maintenance
7 of dental clinics in the public schools of said town shall be
8 expended under the direction of the school committee of said
9 town and that said clinics shall be conducted subject to such
10 rules and regulations as said committee may establish.

1 SECTION 2. This act shall take effect upon its passage.
