AN ACT ESTABLISHING A BOARD OF TRUSTEES OF THE PONDVILLE HOSPITAL.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

2 striking out section 69E, as most recently amended by sec-
3 tion 5 of chapter 546 of the acts of 1962, and inserting in

5 shall be a board of trustees, to be known as the board of
6 trustees of the Pondville hospital, serving in the department
7 and consisting of seven persons, to be appointed by the gov-
8 ernor, with the advice and consent of the council. The com-
9 missioner shall have general supervision and control of the
10 Lemuel Shattuck hospital. Upon written application of a
11 registered physician, the department may admit patients to
12 the Lemuel Shattuck hospital and to the chronic disease sec-
13 tions of the Rutland state sanatorium and the Lakeville state
14 sanatorium, for the treatment of chronic disease, and to the
15 cancer division of the Westfield state sanatorium, for the
16 treatment of cancer and chronic diseases, subject to such rules
17 and regulations as the department may prescribe, and sub-
18 ject to the approval of the trustees, the Pondville hospital,
19 for the treatment of cancer; provided, that preference shall be
20 given to residents of the commonwealth. Any such patient may
21 be discharged from said hospital or sanatorium either upon
22 his own request or upon determination of the department or
23 trustees, but not otherwise. The commissioner may establish
24 outpatient departments at the Lemuel Shattuck hospital and,
25 with the approval of the trustees, the Pondville hospital.
