The Commonwealth of Wassachusetts

In the Year One Thousand Nine Hundred and Twenty-Eight.

An Act providing for Biennial Municipal Elections in the City of Chelsea.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. Beginning with the year nineteen
- 2 hundred and twenty-nine, municipal elections in the
- 3 city of Chelsea for the choice of mayor, aldermen at
- 4 large, aldermen by wards and members of the school
- 5 committee shall take place biennially on the Tuesday
- 6 following the second Monday in December in each
- 7 odd numbered year, and there shall be no annual
- 8 municipal election in said city in the year nineteen
- 9 hundred and twenty-eight. The term of office of every
- 10 alderman at large, alderman by ward and elective
- 11 member of the school committee which would expire
- 12 on the first Monday in January nineteen hundred and
- 13 twenty-nine is hereby extended until the first Mon-
- 14 day in January nineteen hundred and thirty.
 - 1 Section 2. All the aldermen at large and alder-
 - 2 men by wards shall be elected to serve for two years
 - 3 from the first Monday in January following each
 - 4 biennial municipal election and until the qualification
 - 5 of their successors. On the first Monday in January
 - 6 following a biennial municipal election, or on the fol-

7 lowing day when said first Monday is a holiday, at 8 eight o'clock in the evening, the mayor-elect and 9 aldermen-elect shall meet and be sworn to the faithful 10 discharge of their duties. If the full number of mem-11 bers of the board of aldermen shall not be elected or if 12 a vacancy occurs in said board at any time, the re-13 maining members thereof shall declare a vacancy to 14 exist and fill the same for the unexpired term, from 15 among the registered voters qualified to be elected by 16 the people to the office in which the vacancy exists.

- 1 Section 3. At the biennial municipal election in 2 the year nineteen hundred and twenty-nine, two mem3 bers of the school committee shall be elected by and 4 from the registered voters of each ward, one for a term 5 of four years and one for a term of two years, and at 6 each biennial municipal election thereafter one mem7 ber of the school committee shall be elected as afore8 said for a term of four years. All members of such 9 committee shall serve until the qualification of their 10 successors.
- 1 Section 4. So much of chapter six hundred and 2 eighty of the acts of nineteen hundred and eleven, and 3 acts in amendment thereof or in addition thereto, as 4 is inconsistent herewith, is hereby repealed.
- 1 Section 5. This act shall be submitted for ac2 ceptance to the registered voters of the city of Chelsea
 3 at the biennial state election in the current year in the
 4 form of the following question, which shall be placed
 5 upon the official ballot to be used in said city at said
 6 election: "Shall an act passed by the general court in
 7 the current year, entitled 'An Act providing for bi-

8 ennial municipal elections in the city of Chelsea' be

9 accepted?" If a majority of the voters voting thereon

10 vote in the affirmative in answer to said question this

11 act shall thereupon take full effect, otherwise it shall

12 be of no effect.
