## The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Thirty-One.

An Act establishing the Office of Second Assistant Clerk in the Municipal Court of the Brighton District of the City of Boston.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section ten of chapter two hundred  
2 and eighteen of the General Laws, as most recently  
3 amended by section one of chapter one hundred and  
4 fifty-two of the acts of nineteen hundred and thirty,  
5 is hereby further amended by inserting after the  
6 word "district" in the nineteenth line the  
7 words:—, the municipal court of the Brighton  
8 district,—so as to read as follows:—*Section 10.*  
9 The clerk of a district court may, subject to the  
10 approval of the justice, appoint one or more assistant  
11 clerks, who shall be removable at his pleasure or at  
12 the pleasure of the court, for whose official acts the  
13 clerk shall be responsible and who shall be paid by  
14 him unless salaries payable by the county are au-

15 thorized in this section or in section fifty-three.  
16 Assistant clerks with salaries payable by the county  
17 may be appointed in the central district court of  
18 northern Essex, the municipal court of the Charles-  
19 town district, the municipal court of the Brighton  
20 district, the district court of western Hampden, the  
21 district court of Newton, the district court of north-  
22 ern Norfolk and in courts the judicial districts  
23 of which have, according to the national or state  
24 census last preceding, a population of sixty thou-  
25 sand or more. Second assistant clerks with salaries  
26 payable by the county may be appointed in the  
27 municipal court of the Roxbury district, the East  
28 Boston district court, the municipal court of the  
29 Charlestown district, the municipal court of the  
30 Dorchester district, the municipal court of the  
31 Brighton district, the municipal court of the West  
32 Roxbury district, and, subject to the approval of  
33 the county commissioners, in the first district court  
34 of eastern Middlesex, the third district court of  
35 eastern Middlesex, the district court of southern  
36 Essex, the third district court of Bristol and the  
37 district court of East Norfolk.

38 Third assistant clerks with salaries payable by  
39 the county may be appointed in the municipal  
40 court of the Roxbury district and, subject to the  
41 approval of the county commissioners, in the first  
42 district court of eastern Middlesex and the third  
43 district court of eastern Middlesex.

1 SECTION 2. This act shall take effect upon its  
2 acceptance during the current year by vote of the  
3 city council of the city of Boston, subject to the  
4 provisions of its charter but not otherwise.
