1 *Resolved*, That, after an appropriation has been
2 made, there be allowed and paid out of the treasury
3 of the commonwealth from the Highway Fund to
4 Herbert Curtis Shepard of Concord, the sum of
5 four thousand dollars, on account of injuries sus-
6 tained by him in said town of Concord on April
7 twenty-eighth, nineteen hundred and thirty, by
8 reason of being struck by a motor truck owned by
9 the commonwealth and operated by an employee
10 of the department of public works.
