## The Commonwealth of Massachusetts

An Act establishing the Salary of the Clerk of the Supreme Judicial Court for the County of Suffolk.

1 *Whereas*, There is need of legislation to establish  
2 the salary of the clerk of the supreme judicial court  
3 for the county of Suffolk.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Section ninety-four of chapter two hundred and  
2 twenty-one of the General Laws is hereby amended  
3 by inserting at the end thereof the following: —

4 Except that the salary of the clerk of the supreme  
5 judicial court for the county of Suffolk shall be equal  
6 to sixty-five per cent of the salary established for  
7 an associate justice of the supreme judicial court, so  
8 that said section shall read as follows: — *Section 94.*

9 Except as provided in sections ninety-three and  
10 ninety-eight, the salaries of clerks of courts shall be  
11 based upon the population of their respective coun-  
12 ties as determined by the census of nineteen hun-  
13 dred and fifteen, as follows: —

19 Except that the salary of the clerk of the supreme  
20 judicial court for the county of Suffolk shall be equal  
21 to sixty-five per cent of the salary established for an  
22 associate justice of the supreme judicial court.
