AN ACT RELATIVE TO THE DISTRIBUTION OF THE COST OF CON- STRUCTING TOWN AND COUNTY HIGHWAYS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Subdivision (a) of subsection (2) of section 34 of chapter
2 90 of the General Laws, as appearing in section 2 of chapter
3 427 of the acts of 1943, is hereby amended by inserting after
4 the word "highways" at the end of the first sentence the
5 following: — ; provided, however, that sixty per cent of
6 the cost of such repairs, improvements or construction shall
7 be borne by the commonwealth, and that the county and
8 the town in which the same are made shall each bear twenty
9 per cent of the cost thereof.

As it enacted by the Senate and House of Representatives in

1. That the following be and they are hereby enacted as the laws of the Commonwealth:
