AN ACT AUTHORIZING THE METROPOLITAN DISTRICT COMMISSION TO ACQUIRE LAND FOR RECREATIONAL AND PLAYGROUND FACILITIES IN THAT PART OF BOSTON KNOWN AS THE JAMAICAWAY.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. The metropolitan district commission is hereby  
2 authorized and directed to acquire land from the city of Boston  
3 in that part of Boston known as the Jamaica way and maintain  
4 such land as a recreational area and playground with all the  
5 equipment and facilities necessary and incidental thereto.

1 SECTION 2. For said purposes, the commission shall expend  
2 such sums of money as may hereinafter be appropriated  
3 therefor.
