AN ACT EXTENDING THE AUTHORITY OF THE CITY OF QUINCY TO LEASE OR SELL CERTAIN LAND IN THE BROAD MEADOWS SECTION OF SAID CITY.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 2 of chapter 289 of the acts of 1957 is  
2 hereby amended by adding at the end of said section 2 the  
3 following:— However, should the city of Quincy convey the  
4 whole or any portion of said land, including a certain parcel  
5 of land containing about 11.65 acres to be re-acquired from  
6 the United States of America, to the Quincy Electric Com-  
7 pany, then notwithstanding the provisions of this act or the  
8 provisions of any other law, the land so conveyed to or ac-  
9 quired by the Quincy Electric Company may be used for the  
10 construction, maintenance and operation thereon of an  
11 electric generating station with appurtenant facilities, in-  
12 cluding the storage of coal, oil and other fuels necessary for  
13 the proper operation of such station, and that there be no  
14 setback requirement with respect to buildings where said  
15 land abuts the waters of Town river.

1 SECTION 2. This act shall take effect upon its acceptance  
2 by the city council of the city of Quincy, subject to the pro-  
3 visions of its charter.
