RESOLVE

Granting a County Tax for the County of Franklin.

- 1 Resolved, That the following sums are hereby appro-
- 2 priated for the expenses of the county of Franklin, for
- 3 the year nineteen hundred and sixteen: —
- 4 For the interest on county debt, a sum not exceeding
- 5 two thousand dollars.
- 6 For salaries of county officers and assistants, fixed by
- 7 law, a sum not exceeding seven thousand seven hundred
- 8 and fifty dollars.
- 9 For clerical assistance in county offices, a sum not ex-10 ceeding two thousand eight hundred dollars.
- 11 For salaries and expenses of district and police courts,
- 12 a sum not exceeding nine thousand dollars.
- 13 For salaries of jailers, masters and assistants, and sup-
- 14 port of prisoners in jails and houses of correction, a sum
- 15 not exceeding fifteen thousand dollars.
- 16 For criminal costs in the superior court, a sum not ex-17 ceeding three thousand dollars.
- 18 For civil expenses in the supreme judicial and superior
- 19 courts, a sum not exceeding seven thousand three hundred
- 20 dollars.
- 21 For transportation expenses of county and associate
- 22 commissioners, a sum not exceeding two hundred and
- 23 fifty dollars.

- 24 For medical examiners, inquests, and commitments of
- 25 the insane, a sum not exceeding one thousand four hun-
- 26 dred dollars.
- 27 For auditors, masters and referees, a sum not exceed-
- 28 ing twelve hundred dollars.
- 29 For repairing, furnishing and improving county build-
- 30 ings, a sum not exceeding five hundred dollars.
- 31 For fuel, lights and supplies in county buildings, other
- 32 than jails and houses of correction, and for care of the
- 33 same, a sum not exceeding four thousand five hundred
- 34 dollars.
- 35 For highways, including state highways, bridges and
- 36 land damages, a sum not exceeding thirty-five thousand
- 37 dollars.
- 38 For law libraries, a sum not exceeding one thousand
- 39 dollars.
- 40 For pensions, a sum not exceeding three hundred
- 41 dollars.
- 42 For miscellaneous and contingent expenses of the cur-
- 43 rent year, a sum not exceeding eight hundred eighty-four
- 44 dollars and eighty-eight cents.
- 45 For Mount Sugar Loaf reservation, a sum not exceed-
- 46 ing one thousand two hundred dollars.
- 47 For Franklin County Farm Bureau, Inc., a sum not
- 48 exceeding five thousand dollars.
- 49 And the county commissioners of said county are
- 50 hereby authorized to levy as the county tax of said
- 51 county for the current year, in the manner provided by
- 52 law, the sum of eighty-nine thousand dollars, to be ex-
- 53 pended, together with the cash balance on hand and the
- 54 receipts from other sources, for the above purposes.
