AN ACT

To provide for the Certification of Public School
Teachers.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 1. After July first, nineteen hun-
- 2 dred and twenty, no person shall be eligible to
- 3 teach in a public school in any city or town in
- 4 the commonwealth who does not hold a certificate
- 5 issued in accordance with section three of this
- 6 act.
- 1 Section 2. There shall be within the state
- 2 department of education a teachers' certification
- 3 board, which shall be empowered to carry out
- 4 the provisions of this act. The teachers' cer-
- 5 tification board shall consist of five members,
- 6 who shall include the commissioner of education.
- 7 who shall be ex-officio chairman of the said
- 7 Who shall be ex-ometo chairman of the sate
- 8 board, the other four members of which shall be
- 9 a superintendent of schools chosen by the Massa-
- 10 chusetts superintendents' association to serve

11 three years, a principal of a normal school 12 chosen by the normal school principals, who 13 shall serve four years, and two public day school 14 teachers, one of whom shall be chosen by the 15 Massachusetts teachers' association to serve one 16 year, and one by the Massachusetts teachers' 17 federation, to serve two years. As the term of 18 each member expires, his successor shall be 19 chosen in the manner herein provided for a 20 term of four years, and vacancies shall be filled 21 for the unexpired term in like manner. The 22 elections to said board shall be made prior to 23 December first, nineteen hundred and nineteen, 24 and the terms of office shall begin on that date. 25 The members of said board shall be allowed their 26 necessary expenses for travel in connection with 27 attendance on its meetings.

2 shall define the conditions under which said cer3 tificates shall be granted and held, and shall grant
4 certificates to candidates found qualified by
5 examination or otherwise; but any person who
6 shall have served as teacher for a continuous
7 period of not less than six months, immediately
8 preceding May first, nineteen hundred and
9 twenty, in the public schools of the common10 wealth, and any person who has been or shall
11 hereafter be granted a diploma of graduation
12 from a Massachusetts state normal school or
13 the Boston normal school shall be entitled to
14 certification as a teacher under this act: provided,

15 further, that the school committee of any city or

16 town may require, as condition of service in the

17 public schools of such city or town, such quali-

18 fications as it may deem desirable, in addition

19 to those required for certification by the com-

20 missioner of education.

- 1 Section 4. The teachers' certification board 2 shall grant state teachers' certificates to any 3 persons whom a duly qualified board of examiners, 4 appointed by the school committee of any city 5 or town, shall approve for service in the schools 6 of said city or town: provided, that the standards 7 for such approval are, in the judgment of the 8 teachers' certification board, equal at least to 9 those established for state certification by the
- 1 Section 5. The teachers' certification board 2 shall have authority to revoke for cause any cer-3 tificate granted under the provisions of this act, 4 but no certificate shall be thus revoked until due 5 notice of the intention of revoke has been given 6 and, if requested by the teacher, a hearing shall 7 have been held.
- 1 Section 6. Chapter three hundred and seventy-2 five of the acts of nineteen hundred and eleven, 3 and all acts or parts of acts inconsistent herewith, 4 are hereby repealed.
