

HOUSE No. 438

By Mr. Fallon of Clinton, petition of Thomas F. Fallon that owners of utility facilities shall not be reimbursed for the relocation of such facilities when made necessary by certain highway projects. Highways and Motor Vehicles.

AN ACT PROVIDING THAT THE OWNERS OF UTILITY FACILITIES SHALL NOT BE REIMBURSED FOR THE RELOCATION OF SUCH FACILITIES WHEN MADE NECESSARY BY CERTAIN HIGHWAY PROJECTS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 The last paragraph of section 1 of chapter 718 of the acts of
2 1956 is hereby amended by striking out, in lines 11 to 14, inclu-
3 sive, the words “; provided, however, that the commonwealth
4 may reimburse the owner of such utility facilities for the ‘cost
5 of relocation’ as such cost is defined in said act.”

The first section of Chapter 218B, Section 1, which has the effect of adding to the list of persons who are eligible for the office of Governor, the name of the person who is the holder of the office of Governor, is hereby amended to read as follows:

AN ACT TO AMEND CHAPTER 218B, SECTION 1, WHICH HAS THE EFFECT OF ADDING TO THE LIST OF PERSONS WHO ARE ELIGIBLE FOR THE OFFICE OF GOVERNOR, THE NAME OF THE PERSON WHO IS THE HOLDER OF THE OFFICE OF GOVERNOR.

Enacted by the Senate and House of Representatives of the Commonwealth of Massachusetts in General Court assembled, and by the authority of the same, on the following day and at the following place:

1. The first paragraph of section 1 of chapter 218B of the laws of the Commonwealth is hereby amended by striking out the words "or the holder of the office of Governor" and inserting in their place the words "or the holder of the office of Governor, the person who is the holder of the office of Governor".
2. The words "and the holder of the office of Governor" are hereby inserted at the end of the first paragraph of section 1 of chapter 218B of the laws of the Commonwealth.
3. The words "and the holder of the office of Governor" are hereby inserted at the end of the first paragraph of section 1 of chapter 218B of the laws of the Commonwealth.
4. Any reference in any law to the office of Governor shall be construed to refer to the office of Governor, the person who is the holder of the office of Governor.
5. An emergency clause is hereby enacted to read as follows:
