By Mr. Cloherty of Boston, petition of Peter J. Cloherty that provision be made for payment to municipalities in lieu of taxes on certain property acquired by the Commonwealth for highway purposes. Taxation.

AN ACT PROVIDING FOR PAYMENTS IN LIEU OF TAXES ON PROPERTY ACQUIRED BY THE COMMONWEALTH FOR HIGHWAY PURPOSES IN THE YEARS NINETEEN HUNDRED AND FORTY-NINE TO NINETEEN HUNDRED AND SIXTY, INCLUSIVE.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 58 of the General Laws is hereby amended by insert-
2 ing after section 17B, inserted by section 1 of chapter 592 of the
3 acts of 1945, the following section: —
4 *Section 17C.* In nineteen hundred and sixty-one and in every
5 year thereafter, the state treasurer shall, not later than Novem-
6 ber twentieth, pay each city and town in which on January first
7 of such year the commonwealth shall hold real estate acquired
8 by it for highway purposes between January first, nineteen
9 hundred and forty-nine and December thirty-first, nineteen
10 hundred and sixty both inclusive, such amount in lieu of taxes
11 as shall be certified by the commission to the state treasurer as
12 hereinafter provided. In every year aforesaid, the commission
13 shall, not later than August first, determine, for each parcel of
14 real estate acquired and held by the commonwealth as aforesaid,
15 unless at the time of such acquisition such parcel was exempt
16 from taxation, the assessed valuation of such parcel on the
17 three assessment dates next preceding the acquisition of such
18 parcel after the deduction of all abatements, if any, pertaining
19 to such valuation, multiply the average of the valuation so
20 determined by the rate provided for under section fifty-eight

21 of chapter sixty-three, and certify to the state treasurer the
 22 resultant amount together with a description of the parcel suffi-
 23 cient to identify it and the name of the city or town in which it
 24 is situated. If real estate subject to this section was not sepa-
 25 rately assessed on any of said assessment dates, the fair cash
 26 value of the real estate on such date shall for the purposes of
 27 this section be deemed to be the assessed valuation thereof on
 28 such date.

As a condition of the license to sell and distribute alcoholic beverages in the State of Wisconsin, the licensee shall file with the Department of Public Safety a true and correct copy of the following information:

1. A list of all the premises owned or controlled by the licensee, including the name and address of each premises, and the name and address of the person in charge of each premises.

2. A list of all the persons employed by the licensee, including the name and address of each person, and the nature of the duties assigned to each person.

3. A list of all the vehicles owned or controlled by the licensee, including the make, model, year, and license number of each vehicle, and the name and address of the person in charge of each vehicle.

4. A list of all the contracts, leases, or other agreements entered into by the licensee, including the name and address of each party to the agreement, and the nature of the agreement.

5. A list of all the financial statements of the licensee, including the balance sheet, income statement, and statement of cash flows, for each year ending on or before the date of the filing of this information.

6. A list of all the other information required by the Department of Public Safety, including the name and address of each person who has provided such information, and the date when such information was provided.
