AN ACT IN BEHALF OF WILLIAM H. O'BRIEN OF HINGHAM, AN EMPLOYEE OF THE DEPARTMENT OF CORPORATIONS AND TAXATION, FROM AUGUST SEVENTH, NINETEEN HUNDRED AND FIFTY-THREE TO APRIL THIRTIETH, NINETEEN HUNDRED AND SIXTY-TWO.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Notwithstanding the provisions of any general or special law
2 to the contrary, William H. O'Brien of Hingham, an employee
3 of the department of corporations and taxation, from August
4 seventh, nineteen hundred and fifty-three to April thirtieth
5 nineteen hundred and sixty-two, may become a member of the
6 State Employees' Retirement System; provided, that within
7 ninety days of the effective date of this act, he shall deposit in
8 the annuity savings fund of said system an amount representing
9 five per centum of the salaries he received while so employed
10 together with regular interest to date of such deposits; and by
11 making such deposit he shall become eligible to receive a retire-
12 ment allowance as provided in section five of chapter thirty-two
13 of the General Laws, effective as of May first, nineteen hundred
14 and sixty-two.
