The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Sixty-Three.

AN ACT RELATIVE TO CERTAIN DUTIES OF SCHOOL COMMITTEES.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 68 of chapter 71 of the General Laws, as amended
2 by chapter 97 of the acts of 1934, is hereby further amended by
3 striking out the last sentence and inserting in place thereof the
4 following sentence: — The school committee shall have general
5 charge and superintendence of school buildings and grounds, and
6 shall keep the same in good order. At the expense of the city or
7 town, the school committee shall contract for the making of
8 ordinary repairs and for the providing of proper heating, lighting
9 and such other facilities as may be required in protection of the
10 health, safety, comfort and educational interests of the pupils.

Two, the Senate and House of Representatives, in Conference, have passed the following Act, to-wit:

AN ACT TO AMEND AN ACT PASSED IN THE YEAR ONE THOUSAND NINE HUNDRED AND SEVENTEEN, RELATIVE TO THE REGULATION OF THE PRACTICE OF THE PROFESSION OF LAWYERS.

Section 1. The words "and the State Bar Association" in the first section of the act aforesaid, shall be inserted after the word "and" in the second line of the first section of the act aforesaid.

Section 2. The words "and the State Bar Association" in the second section of the act aforesaid, shall be inserted after the word "and" in the second line of the second section of the act aforesaid.

Section 3. The words "and the State Bar Association" in the third section of the act aforesaid, shall be inserted after the word "and" in the second line of the third section of the act aforesaid.

Section 4. The words "and the State Bar Association" in the fourth section of the act aforesaid, shall be inserted after the word "and" in the second line of the fourth section of the act aforesaid.

Section 5. The words "and the State Bar Association" in the fifth section of the act aforesaid, shall be inserted after the word "and" in the second line of the fifth section of the act aforesaid.

Section 6. The words "and the State Bar Association" in the sixth section of the act aforesaid, shall be inserted after the word "and" in the second line of the sixth section of the act aforesaid.

Section 7. The words "and the State Bar Association" in the seventh section of the act aforesaid, shall be inserted after the word "and" in the second line of the seventh section of the act aforesaid.

Section 8. The words "and the State Bar Association" in the eighth section of the act aforesaid, shall be inserted after the word "and" in the second line of the eighth section of the act aforesaid.

Section 9. The words "and the State Bar Association" in the ninth section of the act aforesaid, shall be inserted after the word "and" in the second line of the ninth section of the act aforesaid.

Section 10. The words "and the State Bar Association" in the tenth section of the act aforesaid, shall be inserted after the word "and" in the second line of the tenth section of the act aforesaid.
