AN ACT REQUIRING MEMBERS OF THE TEACHERS' RETIREMENT SYSTEM TO RETIRE AT THE AGE OF SIXTY-FIVE.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 1 of chapter 32 of the General Laws is hereby
2 amended by striking out the definition of "Maximum Age", as
3 appearing in section 1 of chapter 826 of the acts of 1967, and
4 inserting in place thereof the following definition: —

5 "Maximum Age", the age on the last day of the month in
6 which any member classified in Group 1 as provided for in
7 paragraph (g) of subdivision (2) of section three attains age
8 seventy, or is classified in Group 2 or Group 4 attains age
9 sixty-five, or if classified in Group 3 attains age sixty-five,
10 provided that the maximum age for a member of the teachers'
11 retirement system shall be the last day of the month in which
12 such member attains age sixty-five.
