**The Commonwealth of Massachusetts**

In the Year One Thousand Nine Hundred and Seventy-Three.

AN ACT RELATIVE TO THE CONSERVATION AND REGULATION OF CERTAIN LANDS UNDER THE CONTROL OF THE METROPOLITAN DISTRICT COMMISSION.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. The definition of "Ware river watershed" in  
2 section 1 of chapter 737 of the acts of 1972 is hereby amended  
3 by inserting after the word "watershed", in line 1, the word: —  
4 reservation.

1 SECTION 2. The definition of "Quabbin reservoir area" in  
2 said section 1 of said chapter 737 is hereby amended by striking  
3 out, in line 1, the word "area" and inserting in place thereof the  
4 word: — reservation.

1 SECTION 3. Said section 1 of said chapter 737 is hereby  
2 further amended by striking out the definition of "District" and  
3 inserting in place thereof the following definition: —

4 "District", the combined lands identified in this act as the  
5 Ware river watershed reservation and the Quabbin reservoir reser-  
6 vation, which are a portion of the total lands comprising the  
7 Quabbin section of the metropolitan water district.

1 SECTION 4. Section 6 of said chapter 737 is hereby  
2 amended by inserting after the word "five", in line 6, the  
3 words: — , and further the commission may, pursuant to the  
4 bidding laws of the commonwealth, remove such materials from  
5 the reservoir below flow line for the purpose of increasing, im-

6 proving and maintaining reservoir capacity, the proceeds of  
7 which shall revert to the Metropolitan Water District Reservation  
8 trust fund, as provided for under section sixteen.

1 SECTION 5. Section 8 of said chapter 737 is hereby  
2 amended by striking out, in line 10, the words "be used" and  
3 inserting in place thereof the words: — revert to the Metropolitan  
4 Water District Reservation trust fund as provided for under  
5 section sixteen.

1 SECTION 6. Section 10 of said chapter 737 is hereby  
2 amended by striking out, in line 2, the word "area" and inserting  
3 in place thereof the word: — reservation, — and by inserting after  
4 the word "watershed", in lines 2 and 3, the word: — reservation.

1 SECTION 7. Said chapter 737 is hereby further amended by  
2 striking out section 12 and inserting in place thereof the follow-  
3 ing section: —  
4 *Section 12.* There shall be no overnight camping within the  
5 Quabbin reservoir reservation nor within that portion of the Ware  
6 river watershed reservation defined in section eleven, nor shall  
7 tents be erected nor trailers or other vehicular sleeping accommo-  
8 dation be parked overnight therein.

1 SECTION 8. Section 13 of said chapter 737 is hereby  
2 amended by inserting after the word "Watershed", in line 2, the  
3 word: — reservation, — and by striking out, in lines 5, 7, and 11,  
4 the word "area" and inserting in place thereof, in each instance,  
5 the word: — reservation.

1 SECTION 9. Said chapter 737 is hereby further amended by  
2 adding the following section: —  
3 *Section 16.* All monies received by the commonwealth on  
4 account of lumbering, logging or gravel operations conducted by  
5 the metropolitan district commission under the provisions of this  
6 act shall be credited on the books of the commonwealth to a  
7 fund to be known as the metropolitan water district reservation  
8 trust fund, to be expended for the preservation and maintenance  
9 of such reservations as detailed in section one.
