**AN ACT PROVIDING FOR THE APPOINTMENT OF ADDITIONAL ASSISTANT CLERKS IN CERTAIN DISTRICT COURTS.**

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. The first paragraph of section 10 of chapter  
2 218 of the General Laws, as so appearing in section 1 of chapter  
3 75 of the acts of 1973, is hereby amended by inserting after the  
4 line reading “district court of Chicopee” the following:  
5 district court of eastern Essex,  
6 and by striking out the line reading “district court of Peabody”.

1 SECTION 2. The second paragraph of said section 10 of said  
2 chapter 218, as so appearing, is hereby amended by striking out  
3 the line reading “district court of Hampshire” and inserting in  
4 place thereof the following:  
5 district court of Peabody.

1 SECTION 3. The third paragraph of said section 10 of said  
2 chapter 218, as so appearing, is hereby amended by striking out  
3 the line reading “municipal court of the Charlestown district”,  
4 and by inserting in place thereof the following:  
5 district court of Hampshire.

1 SECTION 4. The fourth paragraph of said section 10 of said  
2 chapter 218, as so appearing, is hereby amended by inserting  
3 after the line reading “municipal court of the South Boston  
4 district” the following:  
5 municipal court of the Charlestown district.

1 SECTION 5. The fifth paragraph of said section 10 of said  
2 chapter 218, as so appearing, is hereby amended by striking out  
3 in line reading “municipal court of the West Roxbury district”.

1 SECTION 6. Said section 10 of said chapter 218 is hereby  
2 further amended by striking out the sixth paragraph, as so  
3 appearing.

1 SECTION 7. Said section 10 of said chapter 218 is hereby  
2 further amended by inserting after the fifth paragraph the  
3 following paragraph:

4 Six assistant clerks with salaries payable by the county may be  
5 appointed in  
6 municipal court of the West Roxbury district.

1 SECTION 8. Said section 10 of said chapter 218 is hereby  
2 further amended by striking out the eighth paragraph, as so  
3 appearing.

1 SECTION 9. The ninth paragraph of said section 10 of said  
2 chapter 218, as so appearing, is hereby amended by inserting  
3 before the line reading "municipal court of Roxbury" the  
4 following:

5 district court of Springfield, and

1 SECTION 10. Said section 10 of said chapter 218 is hereby  
2 further amended by inserting after the ninth paragraph the  
3 following paragraph:

4 Ten assistant clerks with salaries payable by the county may  
5 be appointed in:  
6 third district court of eastern Middlesex.
