**The Commonwealth of Massachusetts**

In the Year One Thousand Nine Hundred and Seventy-Three.

**AN ACT PROVIDING FOR AN ADDITIONAL COURT OFFICER IN THE DISTRICT COURT OF BROCKTON.**

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 218 of the General Laws is hereby amended by  
2 striking out section 62, as most recently amended by chapter  
3 1027 of the acts of 1973, and inserting in place thereof the  
4 following section: —

5 *Section 62.* The district and juvenile courts shall have as  
6 many court officers as are designated for each of them in the  
7 following clauses: —

- 59 In the municipal court of the Roxbury district and in the  
60 municipal court of the Dorchester district one court officer shall

61 be designated by the justice of each said court as chief court  
62 officer and one as assistant chief court officer. In the district  
63 court of Chelsea and in the East Boston district court one court  
64 officer shall be designated by the justice of each said court as  
65 chief court officer. In the Boston juvenile court one court officer  
66 shall be designated by the justice of said court as chief court  
67 officer; and two as assistant chief court officers.
