**Chap. 411. AN ACT RELATIVE TO THE EMPLOYMENT OF REGISTERED NURSES IN THE PUBLIC SCHOOLS.**

*Be it enacted, etc., as follows:*

SECTION 1. The first sentence of section 53 of chapter 71 of the General Laws, as appearing in the Tercentenary Edition, is hereby amended by inserting after the word "and", in lines 2 and 9, in each instance, the word:— registered.

SECTION 2. The first sentence of section 53A of said chapter 71, as so appearing, is hereby amended by inserting after the word "school", in line 5, the word:— registered.

SECTION 2A. The second sentence of said section 53A of said chapter 71, as so appearing, is hereby amended by inserting after the word "or", in line 2, the word:— registered.

SECTION 3. Section 53B of said chapter 71, as so appearing, is hereby amended by inserting after the word "and", in line 3, the word:— registered.

SECTION 4. This act shall not apply to any person employed as a nurse by a school committee of a city, town or district prior to or on the effective date of this act.

**Chap. 412. AN ACT AUTHORIZING THE WATER RESOURCES COMMISSION TO TAKE BY EMINENT DOMAIN A CERTAIN TRACT OF LAND LOCATED IN THE TOWN OF NORTHBOROUGH AND THE CITY OF MARLBOROUGH.**

*Be it enacted, etc., as follows:*

The water resources commission, acting for and in behalf of the commonwealth, is hereby authorized to take by eminent domain under chapter seventy-nine of the General Laws or acquire by purchase or otherwise the following described land or easements therein, or both, for the purpose of flood prevention and related purposes including water resources utilization and other purposes and uses as authorized by chapter twenty-one of the General Laws and chapter six hundred and sixty-nine of the acts of nineteen hundred and sixty, as amended, said land being located in the town of Northborough and the city of Marlborough and owned by the town of Northborough and being bounded and described as follows:

Said tract of land is situated on the southwesterly side of Boundary street in the town of Northborough, being more particularly bounded and described as follows:

Beginning at the most northwesterly corner of the parcel herein described on the southwesterly side of Boundary Street at the center line of the Assabet River;

Said tract of land was taken by the town of Northborough for the purpose of erecting a sewage treatment plant and facilities.

**Chap. 413. AN ACT MAKING APPROPRIATIONS FOR THE FISCAL YEAR NINETEEN HUNDRED AND SEVENTY-FIVE FOR THE MAINTENANCE OF BERKSHIRE COUNTY, ITS DEPARTMENTS, BOARDS, COMMISSIONS AND INSTITUTIONS, OF SUNDRY OTHER SERVICES, FOR CERTAIN PERMANENT IMPROVEMENTS, FOR INTEREST AND DEBT REQUIREMENTS, AND TO MEET CERTAIN REQUIREMENTS OF LAW AND GRANTING A COUNTY TAX FOR SAID COUNTY.**

*Be it enacted, etc., as follows:*

SECTION 1. To provide for the maintenance of Berkshire county, its departments, boards, commissions and institutions, of sundry other services, for certain permanent improvements, for interest and debt requirements, and to meet certain requirements of law, the following sums are hereby appropriated, subject to the provisions of law regulating the disbursement of county funds and the approval thereof, for the fiscal year nineteen hundred and seventy-five.
