By Mr. Walsh, a petition (accompanied by bill, Senate, No. 1293) of Joseph B. Walsh, Richard E. Landry, the Massachusetts Teachers Association, William H. Hebert, executive secretary-treasurer, and another for legislation to provide for the recognition of certain teaching service in the public schools of the Commonwealth of Massachusetts as creditable service under certain retirement systems. The Commonwealth of Massachusetts

In the Year One Thousand Nine Hundred and Seventy-Five.

AN ACT PROVIDING FOR THE RECOGNITION OF CERTAIN TEACHING SERVICE IN THE PUBLIC SCHOOLS OF THE COMMONWEALTH OF MASSACHUSETTS AS CREDITABLE SERVICE UNDER CERTAIN RETIREMENT SYSTEMS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Any person who, on the effective date of this act, is a mem-

2 ber of the teachers retirement system and who at any time be-

3 tween September first, nineteen hundred and thirty-three and 4 August thirty-first, nineteen hundred and forty-seven, ren-

4 August thirty-first, nineteen hundred and forty-seven, ren-

5 dered service as a teaching assistant or candidate in training

6 in a public school of the City of Boston for which he either

7 received no compensation or was paid at the rate of fifty cents

8 a day may, within one year from said effective date or such

9 further time as the teachers retirement board in the event of

10 obvious hardship, may in its discretion allow, pay into the 11 annuity savings fund of said retirement system in one sum, or

12 in installments upon such terms and conditions as said retire-

12 in installments upon such terms and conditions as said refire-13 ment board may prescribe, make-up payments in a sum equal

14 to five per cent of his compensation for services so rendered

15 during said period, together with regular interest thereon.

16 Upon the completion of such make-up payments, such member

17 shall receive, for the purposes of retirement under the teach-

18 ers retirement system or under section fifty-seven or fifty-19 eight of Chapter 32 of the General Laws, the same credit for

20 services so rendered as would have been allowed had such serv-

21 ices been rendered by him for regular compensation. In the

22 event any retirement allowance becomes effective prior to the 23 completion of such make-up payments, such member shall, in 24 addition to credit for his actual membership service, be en-25 titled to credit for that proportion of service rendered by him 26 as aforesaid which the total amount of his make-up payments 27 actually made, together with regular interest thereon to the 28 date his retirement allowance becomes effective, bears to the 29 total amount of what his make-up payments, together with 30 regular interest thereon to such latter date, would have been

31 had he made payment thereof in one sum of such latter date.
