AN ACT TO MAKE CERTAIN CLARIFYING AMENDMENTS ON URBAN REDEVELOPMENT CORPORATIONS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 5 of Chapter 121A of the General Laws,
2 as most recently amended by chapter 652 of the acts of 1960,
3 is hereby further amended by striking in line 3, after the word
4 "city", the words "other than Boston".

3 is hereby further amended by adding the following sentence: —
4 All such information, as submitted to the tax commission, the
5 department of corporations and taxation, and the appellate

7 city or town, shall be filed with the department of community
8 affairs and, upon request, made available by said department
9 of corporations and taxation and by said department of com-
10 munity affairs to any person in accordance with the twenty-
11 sixth clause of section 4 of chapter 7 of the General Laws.
