RESOLVE IN FAVOR OF J. ANDREAS DE MARCO

1 *Resolved*, notwithstanding the provisions of any general or
2 special law to the contrary, that for the purpose of dis-
3 charging a moral obligation of the Commonwealth and sub-
4 ject to appropriation, there be allowed and paid out of the
5 state treasury to J. Andreas DeMarco of Boston such wages
6 for the period of July 1, 1968 through June 30, 1970.

Section 115 of the Constitution of the Commonwealth

1. The Commonwealth shall have the power to make laws with respect to the following matters:—
2. The defence of the Commonwealth and the maintenance of the Commonwealth's armed forces.
3. The external relations of the Commonwealth and the conduct of its foreign affairs.
4. The trade and commerce of the Commonwealth and the regulation of trade and commerce between the States and Territories.
5. The taxation of the Commonwealth and the States and Territories.
6. The borrowing of money by the Commonwealth and the States and Territories.
7. The regulation of the Commonwealth's public debt.
8. The regulation of the Commonwealth's public works.
9. The regulation of the Commonwealth's public services.
10. The regulation of the Commonwealth's public utilities.
11. The regulation of the Commonwealth's public health and safety.
12. The regulation of the Commonwealth's public education.
13. The regulation of the Commonwealth's public culture and recreation.
14. The regulation of the Commonwealth's public administration.
15. The regulation of the Commonwealth's public order and discipline.
16. The regulation of the Commonwealth's public morality and decency.
17. The regulation of the Commonwealth's public justice and law.
18. The regulation of the Commonwealth's public peace and good order.
19. The regulation of the Commonwealth's public safety and security.
20. The regulation of the Commonwealth's public welfare and well-being.
