AN ACT PERMITTING THE PRACTICE OF MEDICINE UNDER SUPERVISION BY MEDICAL STUDENTS.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Chapter 112 of the General Laws is hereby amended by striking
2 out section 9a as most recently amended by chapter 534 acts of
3 1972 and inserting in place thereof the following:

4 *Section 9a.* A student of medicine who has creditably
5 completed not less than two years of study in a legally chartered
6 medical school wherever located may practice medicine as
7 authorized by this section, but only under the supervision of an
8 instructor in a legally chartered medical school, which instructor
9 shall be a registered physician in the commonwealth and a duly
10 appointed staff physician in the duly licensed hospital of not less
11 than twenty-five beds, or an associated clinic, to which the
12 student is assigned. Said students of medicine shall not sign
13 certificates of births or deaths, nor prescribe or dispense narcotic
14 drugs as defined in section one of chapter ninety-four c.
